• **FY16 Budget Reduction Training** – Multiple training sessions were held this week by the Budget Office and Human Resource Services to discuss the permanent budget reduction process and answer questions as departments are preparing their proposals to be submitted at the end of the month. • Landscaping around the Spiritual Center - Structural Maintenance and Grounds shop personnel have been working to complete the landscaping project at the Spiritual Center. The mow strips have been installed and the crews are Xeriscaping the areas next to the building. After the Xeriscaping is completed Grounds will plant grass in the transition area between the xeriscaping and existing turf area. This project has a scheduled completion date of May 22, 2015 and the crews are on track to complete the work as scheduled.

- External Auditors Selected for FY2015 Audit On April 20th, the Regents' Audit Committee approved for KPMG, LLP to serve as the university's independent public accounting firm to perform the annual financial and compliance audit for NMSU. The fully executed contract for Audit Services was received from the Office of the State Auditor on May 5<sup>th</sup>. An entrance conference was held on May 11<sup>th</sup> with the Regent's Audit Committee. KPMG will be here on campus on May 18<sup>th</sup> to begin their planning work.
- Housing and Campus Life Housing and Campus Life successfully closed all of the residence halls and the majority of the campus apartments at the end of the spring semester. Summer housing is now available for students throughout campus.



• Facilities and Services (FS) FIRE - A representative of FS Fire was given the honor of the

ceremonial first pitch at the Aggies vs North Dakota baseball game on Thursday, May 14<sup>th</sup>. Firefighter Dominick Coughlin fired in a STRIKE to get the game started.

Both items were submitted on May 1 to the NMHED and were approved by the Board of Regents on Friday, May 8<sup>th</sup> at their regular scheduled meeting.
